
In accordance with the decision on appeal that was made on July 2, 2008, by Judge Fred Torrisi, Third Judicial District, a Certificate of Need is granted to the joint venture partners to build South Anchorage Ambulatory Surgery Center with the following conditions:

South Anchorage Ambulatory Surgery Center, a joint venture between Providence Health System in Alaska and Advanced Pain Centers of Alaska, is authorized to spend a total of \$6,500,000 to build out a four-suite, 20,100 square foot surgical facility in an existing building located at 88th and Toloff in Anchorage. The approved completion date for the project is December 31, 2009.

A condition of approval is that any "shelled in" or other space planned for conversion to additional surgical suites at a later date must go through the Certificate of Need process and be approved by the Department, regardless of the cost, prior to expending any funds for conversion or operation.
