

**NOTICE OF RECEIPT OF AN APPLICATION FOR A CERTIFICATE OF NEED
THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES**

The Department of Health and Social Services (DHSS) has accepted as complete a certificate of need application for the health care facility construction project described below. In accordance with 7 AAC 07.060, it will conduct a review of the complete application.

Project/Activity: Fairbanks Medical Imaging, LLC, d/b/a North Star Radiology built/renovated a 4,800 square foot space. The project added a Computed Tomography unit, expanded Fluoroscopy (X-ray) services, and replaced a Magnetic Resonance Imaging machine. The estimated project cost was \$2,153,392. The project was completed in July 11, 2011.

Project/Activity Service Area: Fairbanks, Alaska

The application is declared complete and in accordance with AS 18.07, a staff analysis of the application and recommendation must be submitted to the Commissioner by January 28, 2014, unless additional time, not to exceed 30 days, is granted by the Commissioner. A decision by the Commissioner must be made within 45 days of receipt of the staff recommendation unless additional public notice is given that more time is required for the Commissioner to make a decision.
